What is Drive Clean Indiana?

Drive Clean Indiana (DCI) is a 501(c)3 nonprofit organization managed by Legacy Environmental Services, Inc., an Indiana Certified Women's Business Enterprise. Designated as the 71st Clean Cities Coalition on June 15, 1999, DCI is one of the U.S. Department of Energy's more than 75 Clean Cities Coalitions and is the only Clean Cities coalition in the state of Indiana.

The organizations support the nation's energy and economic security by building partnerships to advance affordable domestic transportation fuels, energy-efficient mobility systems, and other fuel-saving technologies and practices.

Mission

Drive Clean Indiana is an Indiana nonprofit organization working to advance clean transportation and equitable mobility to improve air quality and reduce greenhouse gases in our state through education, training, consulting, grant funding, and the development of statewide stakeholder partnerships. (DCI) is Indiana's only Clean Cities Coalition that is recognized/supported as part of the U.S. Department of Energy's (DOE) Vehicle Technologies Office.

Strategies

- ◆ Evaluate Indiana's transportation needs and energy choices to determine the most impactful and cost-effective vehicle options, fuels, technologies, and best practices that make sense for specific stakeholder applications;
- ◆ Decarbonize Indiana's transportation sector by shifting to vehicles, fuels, and technologies that reduce transportation greenhouse gas emissions;
- ◆ Reduce Indiana transportation emissions that contribute to air pollution and harm public health;
- ◆ Shift Indiana fleets to efficient and clean energy sources through the use of alternative and renewable fuels;
- ◆ Improve Indiana's fuel efficiency through state-of-the-art technologies and strategies including idle reduction;
- ◆ Demonstrate and assess new mobility choices that maximize the return on investment for mobility systems in terms of time, cost, energy, and opportunity;
- ◆ Advance Indiana energy and environmental justice priorities by maximizing project benefits that flow to underserved communities and minimize project burdens that affect underserved communities; and increase equitable access to clean, affordable transportation
